## **BILECO implements** reconductoring project

In response to the worsening problem on power quality and system loss which has long beleaguered the distribution system, BILECO had implemented the reconductoring project in the third quarter of 2016.

The project was the brainchild of the OIC General Manager Gerardo N. Oledan as the immediate feasible solution to address the worsening situation of BILECO's aging distribution line. Said project was in line with the Coop's mandate to provide a reliable, safe, quality and efficient electric service in its franchise area and the province of Biliran.

In an energy forum with stakeholders, Oledan recalled BILECO's capital

expenditure (CAPEX) application filed in 2011 with the Energy Regulatory Commission (ERC). The application contains major network projects like the construction of a new sub-station, construction of a 69-kV line between Biliran and Naval and the re-configuration of feeders where a separate line will be dedicated to business establishments and public buildings in the capital town.

Oledan professed, however, that said application is still pending for approval by the Commission which left the Coop no option but avail alternative way to solve the existing problem with urgency. The decision to single out reconductoring project as the best option came after



# **Sec Luistro meets with BILECO ALS enrollees**

## **RENAGMEC** holds competitive selection process for long-term base load demand

The 11 Electric Cooperatives (ECs) in Region 8 namely DORELCO, LEYECO II, LEYECO III, LEYECO IV, LEYECO V, SOLECO, BILECO, SAMELCO I, SAMELCO II, ESAMELCO and NORSAMELCO agreed through a Memorandum of Agreement (MOA) backed by board resolutions of each EC, to jointly conduct a Competitive Selection Process (CSP) for their base load power supply for 2019 to 2038.

The objective of the said undertaking is to secure the supply of electricity for the captive customers and to mitigate the risks in the electricity market through bilateral power supply contracts. Likewise, it also aims to achieve least-cost supply of power



through joint power supply planning and competitive procurement process that can be justly and reasonably passed-on to the member-consumers.

In 2015, the RENAGMEC, Region 8 association of ECs, received an unsolicited proposal from GNPower Dinginin Ltd. Co. to supply their aggregated 150 MW uncontracted demand for the contract years 2019-2038. The price of the proposal is equal to the latest lowest power rate in the Philippines achieved through a competitive bidding process but without the risks of power plant outages. In accordance with the agreed policies of Region 8 ECs for Joint **Competitive Power Supply Procurement** (R8 JCPSP), the RENAGMEC accepted the said proposal and declared the GenCo, through a board resolution, as original proponent of an unsolicited proposal that will be subjected to CSP through Comparative Proposals which is also known as Swiss Challenge.

The R8 JCPSP Board composed of all the Board Presidents and General Managers of the 11 Region 8 ECs created the Region 8 Bids and Awards Committee (R8 BAC) and Technical Working Group (TWG) and appointed


## **BOD** approves coop's new vision, mission

The Board of Directors of the Biliran Electric Cooperative, Inc. (BILECO) had approved the coop's new vision and mission statements through a Board Resolution passed during the Board meeting on April 18, 2016.

The newly crafted vision and mission was a product of the seminarworkshop on Strategy Formulation and Execution spearheaded by the National Electrification Administration (NEA) held at Cebeco 3, Toledo City, Cebu on April 11 to 15.

With its ambitious yet inspiring vision, the long-term plan covering the years 2016 to 2030 enumerated capital expenditure projects and major innovations and programs that will usher re-engineering and reforms in its overall operation.

The projects incorporate extensive upgrading of distribution lines and facilities, acquisition and development of state-of-the-art technology and IT infrastructures and major physical development.

The Board also approved its new corporate values with acronym GoD HEART. It stands for Godliness, Discipline, Honesty, Excellence, Accountability, Respect and Teamwork.

## **DOLE awards BILECO 3 certificates of compliance**

The Department of Labor and Employment (DOLE) awarded three certificates of compliance (COCs) to BILECO during the awarding ceremony on October 30, 2015 at DOLE Training Center, Tacloban City.

Secretary Rosalinda Dimapilis-Baldoz personally handed down the COCs to the OIC-GM, Engr. Gerardo N. Oledan, and BILECO Employees Union President, Mr. Albert B. Pitao.

BILECO was the first and only cooperative-awardee electric in the region which was conferred certificates of compliance (COC) on General Labor Standards (GLS), Occupational Safety & Health (OSH) and Labor Relations. The COC was all about achieving voluntary compliance with labor laws and standards aimed at providing conducive workplace environment promoting the overall welfare of its

#### employees.

Baldoz said after the awarding ceremony that the number of establishments that the regional office has assessed and awarded Certificate of Compliance (CoCs) under the Labor Laws Compliance System (LLCS) is one concrete proof that Region 8 is on the rise.

## General assembly decides to stick with NEA

The issue on conversion had finally come to a close after the general assembly favored to retain BILECO's non-stock, nonprofit status under NEA.

BILECO held its 29th Annual General Membership Assembly (AGMA) meeting on November 26 at the Cabucgayan Gym in Magbangon, Cabucgayan.

This year's event was anchored on the theme "Kabag-uhan ug Kalambuan - sa 33 Malauman ang Katumanan," which aptly underscores the Coop's optimism towards a better change through organizational and operational reforms.

Prof. Rowaldo A. Del Mundo, UP professor and guest speaker of the event, discussed with the members the operation of an electric distribution utility, its strengths, weaknesses and scope, and reminded them on their responsibilities and obligations to the Coop as members.

Cong. Rogelio J. Espina also graced the occasion spearheading the formal switch-on and energization of the 78 sitios under NEA Sitio Electrification Program. He commended BILECO for its commitment to service through electrification to its fellow Biliranons.

A total of 3,103 members have attended the gathering equivalent to 10.68% of the total membership.

#### **ISSUE ON CONVERSION**

One of the agenda discussed during the plenary was the conversion issue pursuant to Republic Act No. 10531.

The law provides option for ECs to either remain as nonstock, non-profit under NEA, convert into a stock cooperative under CDA or convert into a stock corporation under SEC.

Several months prior to the annual assembly, series of district meetings were conducted in all districts in order to educate the members of the advantages and disadvantages of conversion. Likewise, the Coop also sought support from the local governments, barangay officials and other stakeholders by keeping them involved and informed on the matter.

The certificate of membership decision revealed that the general assembly favored that BILECO



remains status quo under NEA considering that it is the most beneficial for the Coop.

The result of the referendum will take effect for the next 10 years from the date of its adoption.

third party transaction advisors to design and execute the CSP.

To test the market whether the offered rate is the lowest, generation companies were invited to participate in the transaction through publication in newspapers of general and national circulation for two (2) consecutive weeks and through written invitation to all Generation Companies (GenCos) listed in the Department of Energy's website. Two GenCos responded the invitation and purchased the bid documents while only one of the two submitted its actual bid. Result of the Bid Opening which was held at Lex Hotel, Cebu City last October 24, 2015 revealed that, still the Original Proponent's offered rate is the lowest in the market. GNPower Dinginin Ltd. Co. was awarded with Power Supply Agreement (PSA) equivalent to the aggregated demand of the region's ECs. Each EC signed individual but identical PSA with the winning proponent for their respective committed capacities, to wit:

citizenship in the realm of labor laws compliance.

"To sustain our inclusion in the roster of compliant establishments, we need to be conscious on our responsibilities to faithfully comply with labor regulations. I hope this recognition will serve as the gateway in promoting the Coop's best practices among industries," OIC-GM Oledan added.

Mr. Pitao also expressed elation on

the successful result of collaborative effort between the management and employees which primarily focused on enhancing employer-employee relationships and productivity.

"I am very delighted and proud that we have substantially complied with the requirements on labor laws. Let us remain steadfast in implementing all our programs geared towards creating conducive work atmosphere and producing competitive and productive workforce," he added.

BILECO will be exempted from

the annual joint assessment by DOLE within two years provided it will continue its collective effort in the said compliances. Further, BILECO is staunchly committed to promote industrial peace through labor standards practice.

More than 500 establishments in Region 8 were awarded COCs. Director Cayanong of DOLE-RO8 reported to the Secretary 300 more establishments will be issued CoCs before the end of the year 2015.

# Rostata is new director of Naval

Engr. Reynaldo B. Rostata of the Philippine Statistics Authority was named the new Board of Director in the district of Naval during the conduct of a special district election on December 10, 2016.

The said post was vacant since 2013 after RA 10531 or the National Electrification Administration Reform Act of 2013, where qualifications and disqualifications for directorship became more 'stern', came into full force. NEA emphasized that no holdover capacity shall be

allowed for directors whose term already expired which resulted to vacancies.

Rostata took his oath of office on December 22 during the year-end Board meeting.

However, in the district of Kawayan, where the regular and special elections were held alongside Naval, resulted to a failure of election due to similar predicaments on qualifications.



A memorandum was issued by NEA in 2014 providing options for electric cooperatives with vacant BODs. The Multisectoral Electrification Advisory Council (MSEAC) can appoint among themselves a representative to the Board, provided however, that the nominee is qualified under the provisions of RA 10531. Also, the incumbent Board may select among themselves a caretaker to the district where the vacancy occurred.

management for the initiative and the enrollees for taking time to pursue their studies considering the demands of work and family.

The Secretary also complimented BILECO's commitment of support in the implementation of Senior High School through a Memorandum of Agreement for work immersion partnership. DepEd started the full implementation of SHS in school year 2016-2017.

an exhaustive study on costbenefit analysis and other technical considerations. The project was funded from a loan obtained from NEA amounting to P8 million with no rate impact on the part of the consumers.

The project which commenced on July 17, aimed to replace the existing three-decade old 2/0 ACSR cable with 336.4 ACSR in Feeder 1 and 4/0 ACSR in Feeder 2. The scope of the project covers a distance of 14 kilometers in Feeder 1 between San Roque, Biliran (Sub-station) to Atipolo, Naval and another 16 kilometers in Feeder 2 between San Roque, Biliran (Sub-station) to Bunga, Cabucgayan.

Replacement of cables required a series of outages every week for a period of five months based on the tentative work schedule by the Technical Services. With the demands to allay the inconvenience of the project, BILECO, in consultation with its stakeholders, decided to ask assistance from Region 8 ECs through a Task Force Kapatid composed of more than 100 linemen. The 12 successive Saturdays of interruption was shortened to just three consecutive days from September 9 to 11 in Feeder 1.

Oledan expressed his gratefulness to the members of Region 8 electric cooperatives for their support and assistance in advancing and fulfilling its mission.

#### **IMPACT OF THE PROJECT**



True to its projected outcome, a historic drop of system loss was reported based on the Coop's latest Monthly Financial Statistical Report (MFSR), the lowest in the recent years.

The December 2016 data revealed a system loss with SSLA of 6.57% compared to 16.33% in July of the same year, right before the implementation of the project. System loss is one of the performance indicators under the Key Performance Standards (KPS) and the EC Categorization which determines the performance rating of an electric cooperative. The Coop's performance for the years 2014 and 2015 lagged behind due to its high losses.

Although system loss made a remarkable improvement in the last quarter, the average losses for the year 2016 is still at 13.85%, still beyond the cap of 13% set forth by the National Electrification Administration.

The management and the Board are committed to sustain the momentum by intensifying and prioritizing projects for system loss reduction for the year 2017 onwards.
