
Sealed bids (hard copies) must be received by the BAC Secretariat on or before the deadline for submission and opening of bids.

The Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in "The 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184," otherwise known as the government procurement reform act.


