The Pre-Bid Conference and the Bid Opening shall be conducted on a face-to-face basis in the BILECO Boardroom, 2nd floor of the main office building, Brgy. Caraycaray, Naval, Biliran, unless otherwise authorized under applicable procurement laws, rules, or issuances. Only bidders who have purchased the Bidding Document, or their duly authorized representatives, may attend the Pre-Bid Conference and Bid Opening.

Sealed bids (hard copies) must be received by the BAC Secretariat on or before the deadline for submission and opening of bids.

The Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in NEA Revised Procurement Guidelines and Simplified Bidding Procedures for Electric Cooperatives IRR and applicable rules of **RA 10531**.

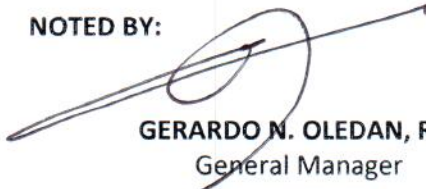
